RESOLUTION NO. 2013 - 110

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED BID #FY2012-2013-009, FURNISHING AND INSTALLING PLANTS FOR THREE ISLANDS BOULEVARD MEDIANS PROJECT TO THE LOWEST, RESPONSIBLE, RESPONSIVE BIDDER, VISUALSCAPE, INC., IN THE AMOUNT NOT TO EXCEED NINETY THREE THOUSAND SEVEN HUNDRED EIGHTY FIVE (\$93,785.00) DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH VISUALSCAPE, INC.; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the furnishing and planting for Three Islands Boulevard Medians Project was created to upgrade existing medians along Three Islands Boulevard from Hallandale Beach Boulevard to Hollywood City limits; and

WHEREAS, the project will beautify the medians by adding solid shrubs and eliminate the use of a mowing crew while reducing one layer of maintenance; and

WHEREAS, on July 12, 2013 Invitation to Bid BID #FY 2012-2013-009, Furnishing and Installing Plants for Three Islands Boulevard Medians Project, was advertised in the sun sentinel and vendors were notified through electronic mail; and

WHEREAS, on August 9, 2013 four (4) bids were received and all four (4) responsive vendors met the minimum qualifications; and

WHEREAS, of the four (4) responsible, responsive bidders, Visualscape, Inc., offered the lowest rates; and

WHEREAS, City staff has evaluated and reviewed all responses received by the four (4) vendors and recommend City Commission award of BID #FY2012-2013-009, Furnishing and Installing Plants for Three Islands Boulevard Medians Project to Visualscape Inc., as the lowest responsive, responsible bidder; and

WHEREAS, City Administration further recommends that City Manager be authorized to execute an agreement in substantially the same form as attached in Exhibit 2 with Visualscape

38 Inc., in the amount not to exceed Ninety Three Thousand Seven Hundred Eighty-Five dollars

41 **WHEREAS**, the Mayor and City Commission have determined that the City

44 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION**
45 **OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

47 **SECTION 1. City Commission Action.** The Mayor and City Commission hereby
48 award BID #FY2012-2013-009, Furnishing and Installing Plants for Three Islands Boulevard
49 Medians Project to Visualscape Inc. as the lowest responsive, responsible bidder.



52 authorize the City Manager to execute an agreement with Visualscape, Inc. in substantially the
53 same form as attached in Exhibit 2, for an amount not to exceed Ninety Three Thousand Seven
54 Hundred Eighty-Five dollars (\$93,785.00). The City Manager is authorized to take necessary
55 action to implement the project.


