RESOLUTION NO. 2015 - 09

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED RFP #FY2013-2014-015 TO CAFÉ CITA ON THE BEACH TO OPERATE THE SOUTH BEACH CONCESSION; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND BRING BACK A LICENSE/OPERATIONS AGREEMENT WITH CAFÉ CITA ON THE BEACH; AND FURTHER AUTHORIZING THE CITY MANAGER TO NEGOTIATE WITH THE SECOND RANKED FIRM IN THE EVENT THE NEGOTIATIONS WITH CAFÉ CITA ON THE BEACH ARE NOT SUCCESSFUL AND BRING BACK A LICENSE/OPERATIONS AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, on January 24, 2014, the Procurement Department issued Request
17 for Proposal (RFP) FY2013-2014-015 for the South Beach Concession, and received no
18 responses. On July 24, 2014, RFP #FY2013-2014-015 was re-released and four (4)
19 proposals were received; and
20

21 **WHEREAS**, on August 1, 2014, a non-mandatory pre-proposal meeting was held,
22 and based on questions posed by various firms one RFP addenda was issued, with a due
23 date for all proposals was August 22, 2014; and
24

25 **WHEREAS**, on October 20, 2014, oral presentations were held which included
26 sampling of the menus from each proposer; and
27

28 **WHEREAS**, upon conclusion of the oral presentations, the evaluation committee
29 ranked the four (4) firms based on the firms qualification and experience, past
30 performance, financial resources, approach to the project, local vendor preference and
31 community benefit plan., The evaluation selected Café Cita on the Beach (YC Group #1
32 BDA Café Cita-Forty Eight Equities, Inc.) as the highest weighted ranked proposal; and

34 **WHEREAS**, the City Administration evaluated the proposal from Café Cita on the
35 Beach, and finds that Café Cita on the Beach is qualified to provide services for the South
36 Beach Concession; and
37

38 **WHEREAS**, the City Administration recommends City Commission approval to
39 award RFP #FY2013-2014-015 and authorize the City Manager to negotiate and execute
40 an agreement with Café Cita on the Beach to provide services for the South Beach
41 Concession; and

43 **WHEREAS**, the City Administration further recommends the City Commission
44 authorize the City Manager to negotiate with the second ranked firm in the event that
45 negotiations with Café Cita on the Beach are not successful; and

46

47 **WHEREAS**, the Mayor and City Commission has determined that it is in the best
48 interest of the City and its residents to authorize the City Manager to negotiate and bring
49 back a license/operations agreement with Café Cita on the Beach for South Beach
50 Concession.

52 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
53 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

55 **SECTION 1. City Commission Award.** The Mayor and City Commission hereby
56 award RFP #FY2013-2014-015 to Café Cita on the Beach for the South Beach
57 Concession.

58

59 **SECTION 2. City Manager Authority.** The City Manager is authorized to
60 negotiate and to bring back a license/operations agreement with Café Cita on the Beach
61 for South Beach Concession for City Commission approval. In the event negotiations
62 with Café Cita on the Beach are not successful, the City Manager is authorized to
63 negotiate with the second ranked firm and to bring back a license/operations agreement
64 for South Beach Concession for City Commission approval.

66 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon
67 its passage and adoption.

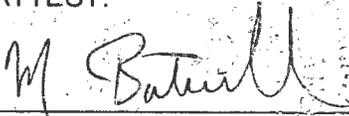
