**RESOLUTION NO. 2018-017**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDDING BID #FY 2017-2018-005, 8" WATER MAIN NE 2<sup>ND</sup> AVENUE AND NE 2<sup>ND</sup> TERRACE IMPROVEMENTS TO THE LOWEST, RESPONSIVE BIDDER, V. ENGINEERING & CONSULTING CORP.; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH V. ENGINEERING & CONSULTING CORP. IN AN AMOUNT NOT TO EXCEED EIGHT HUNDRED THIRTY-THREE THOUSAND FIVE HUNDRED THIRTY-NINE DOLLARS (\$833,539) INCLUSIVE OF A TEN PERCENT CONTINGENCY OF SEVENTY-FIVE THOUSAND SEVEN HUNDRED SEVENTY-SIX DOLLARS (\$75,776), AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT TO EFFECTUATE THE PROJECT; AND PROVIDING FOR AN EFFECTIVE DATE.**

21           **WHEREAS**, pursuant to Section 23-4 of the City of Hallandale Beach Code of  
22 Ordinances, all purchases of and contracts for equipment, supplies and contractual  
23 services, when the estimated cost shall exceed \$50,000 shall be based on competitive  
24 bids. Furthermore, pursuant to Section 23-6, the City Manager shall have the authority to  
25 recommend to the City Commission award of contracts; and

27           **WHEREAS**, on December 6, 2017, the City released BID #FY 2017-2018-005, 8"  
28 Water Main NE 2<sup>nd</sup> Avenue and NE 2<sup>nd</sup> Terrace Improvements; and

30           **WHEREAS**, on December 20, 2017, a non-mandatory Pre-Bid Conference was  
31 held at 11:00 AM and eight (8) vendors were in attendance; and

32           **WHEREAS**, seven (7) bids were received from V. Engineering & Consulting Corp.,  
33 Southeastern Engineering Contractors Inc., Sun Up Enterprises, Metro Express, R.P.  
34 Utilities and Excavation Corp., Florida Engineering and Development, and West Wind  
35 Contracting; and

36           **WHEREAS**, V. Engineering & Consulting Corp. provided the lowest responsive bid  
37 at seven hundred fifty-seven thousand seven hundred sixty-three dollars (\$757,763); and


