

40 **WHEREAS**, the City Administration recommends that the City Commission award
41 Re-Bid #FY-2017-2018-004-001, A1A Bus Shelter Improvements to the lowest responsive
42 responsible bidder, C&I Construction and Design, Inc. in an amount not to exceed sixty
43 one thousand forty dollars and eighty four cents (\$61,040.84), inclusive of a ten percent
44 (10%) contingency in the amount of five thousand five hundred and forty nine dollars and
45 seventeen cents (\$5,549.17). The City Administration further recommends authorization
46 for the City Manager to execute an agreement to effectuate the project; and

49 Administration's recommendations are in the best interest of the City and its residents.

54 **SECTION 1. City Commission Action.** The Mayor and City Commission
55 hereby award Re-Bid #FY-2017-2018-004-001, A1A Bus Shelter Improvements to the
56 lowest responsive responsible bidder, C&I Construction and Design, Inc.

58 **SECTION 2. City Manager Authorization.** The Mayor and City Commission
59 hereby authorize the City Manager to negotiate and execute an agreement with C&I
60 Construction and Design, Inc. in an amount not to exceed sixty one thousand forty dollars
61 and eighty four cents (\$61,040.84), inclusive of a ten percent (10%) contingency in the
62 amount of five thousand five hundred and forty nine dollars and seventeen cents
63 (\$5,549.17). The City Manager is further authorized to execute an agreement to effectuate
64 this project.

66 **SECTION 3. Effective Date.** This Resolution shall become effective immediately
67 upon its adoption.
