RESOLUTION NO. 2016 - 01

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED BID #FY2015-2016-002, WATER TREATMENT PLANT COATINGS AND STUCCO REPAIRS TO HARTZELL PAINTING IN AN AMOUNT NOT-TO-EXCEED TWO HUNDRED SEVENTY THOUSAND TWO HUNDRED FIFTEEN DOLLARS (\$270,215.00); AUTHORIZING A TWENTY PERCENT (20%) CONTINGENCY FOR UNFORESEEN CIRCUMSTANCES; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE AGREEMENT WITH HARTZELL PAINTING; AND PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, the membrane water plant located in the Public Works compound was
17 constructed in February 2008; and

18
19 **WHEREAS**, the water plant should be re-painted every five to seven years, therefore this
20 project was created in order to paint the exteriors of the membrane plant, generator building,
21 degasifier facility, high service pump building; filter buildings, chemical storage containment walls,
22 backwash return basin, above ground piping; and

23
24 **WHEREAS**, in inspection of the large sanitary system at the Public Works compound by
25 the Broward County Health Department, and the report noted that the above ground pipes at the
26 water plant are required to be color coded; and

27
28 **WHEREAS**, on October 9, 2015, an Invitation to Bid #FY 2015-2016-002, for the Water
29 Plant Coatings and Stucco Reports, was provided to forty four (44) potential vendors, and a
30 mandatory pre-bid meeting and site visit were held on October 19, 2015; and

32 **WHEREAS**, a total of three (3) bids were submitted on November 9, 2015. Staff
33 evaluated the responses from the vendors, and selected Hartzell Painting as the lowest,
34 responsive, responsible bidder. Hartzell Painting submitted a bid in the amount of two hundred
35 seventy thousand two hundred fifteen (\$270,215.00) dollars; and

37 **WHEREAS**, the City Administration recommends the award of Bid #FY2015-2016-002,
38 Water Treatment Plant Coatings and Stucco Repairs to Hartzell Painting as the lowest
39 responsive, responsible bidder.

41 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR CITY COMMISSION OF THE
42 CITY OF HALLANDALE BEACH, FLORIDA:

44 **SECTION 1. City Commission Award.** The Mayor and City Commission hereby award
45 Bid #FY 2015-2016-002, Water Treatment Plant Coatings and Stucco Repairs, to the lowest
46 responsive, responsible bidder Hartzell Painting in an amount not-to-exceed two hundred seventy
47 thousand two hundred fifteen (\$270,215.00) dollars.

49 **SECTION 2. City Manager Authorization.** The Mayor and City Commission hereby
50 authorize the City Manager to execute an agreement with Hartzell Painting in an amount not-to-
51 exceed exceed two hundred seventy thousand two hundred fifteen (\$270,215.00) dollars, and
52 authorizing a twenty percent (20%) contingency for unforeseen circumstances. The City Manager
53 is authorized to execute all related documents to effectuate this project.

55 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its
56 passage and adoption.
