RESOLUTION NO. 2016 - 06

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED BID #FY2015-2016-001, SALT WATER MONITORING WELL PROJECT TO HAUSINGER & ASSOCIATES IN AN AMOUNT NOT TO EXCEED ONE HUNDRED FIFTY FIVE THOUSAND FOUR HUNDRED SIXTY DOLLARS (\$155,460.00); AUTHORIZING A TEN PERCENT (10%) CONTINGENCY FOR UNFORESEEN CIRCUMSTANCES; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on August 21, 2013, the City approved Resolution 2013-82, adopting the allocation of water supply from the Hallandale Beach and Broward County well fields as the City’s water supply and treatment strategy; and

WHEREAS, the City initiated a Well Revitalization Project which includes the installation of saltwater monitoring wells; and

WHEREAS, the City will extend the saltwater monitoring network as required by the South Florida Water Management District in the City’s ongoing Water Use Permit Application; and

WHEREAS, pursuant to chapter 23, Section 23-4, Competitive Bidding Required, all contracts for equipment, supplies, and contractual services shall be based on competitive bids when the estimated cost exceeds \$50,000; and

WHEREAS, the City released an Invitation to Bid and notified eleven (11) vendors via email to submit a bid for the Salt Water Monitoring Well Project; and

WHEREAS, three (3) vendors attended the mandatory pre-bid conference, and a total of three (3) bids were submitted on November 6, 2015, and evaluated by City Administration; and

39 **WHEREAS**, the City Administration has selected Hausinger & Associates as the
40 lowest, responsive, responsible bidder with a bid amount of One Hundred Fifty Five
41 Thousand Four Hundred Sixty Dollars (\$155,460.00); and

43 **WHEREAS**, the City Manager recommends awarding Bid #2015-2016-001
44 Saltwater Monitoring Well Project to Hausinger & Associations, for an amount not to
45 exceed One Hundred Fifty Five Thousand Four Hundred Sixty Dollars (\$155,460.00), with
46 a ten percent (10%) contingency for unforeseen circumstances.

48 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY**
49 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

50 **SECTION 1. City Commission Award.** The Mayor and City Commission award
51 Bid #FY 2015-2016-001 to Hausinger & Associates for an amount not to exceed One
52 Hundred Fifty Five Thousand Four Hundred Sixty (\$155,460.00) Dollars with a ten percent
53 (10%) contingency for unforeseen circumstances.

55 **SECTION 2. City Manager Authorization.** The Mayor and City Commission
56 hereby authorize the City Manager to execute an agreement with Hausinger & Associates
57 in an amount not to exceed One Hundred Fifty Five Thousand Four Hundred Sixty
58 (\$155,460.00) Dollars, and authorizing a ten percent (10%) contingency for unforeseen
59 circumstances. The City Manager is authorized to execute all related documents to
60 effectuate this project.

62 **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon
63 its passage and adoption.
