RESOLUTION NO. 2015 - 147

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED BID #FY2014-2015-018, 40th YEAR COMMUNITY DEVELOPMENT BLOCK GRANT (“CDBG”) PUBLIC WORKS IMPROVEMENT BLOCK GRANT PROJECT, TO THE LOWEST RESPONSIVE, RESPONSIBLE BIDDER SUN UP ENTERPRISES INC. IN AN AMOUNT NOT-TO-EXCEED ONE HUNDRED SIX THOUSAND NINE HUNDRED NINETY NINE DOLLARS (\$106,999.00); AUTHORIZING A TEN PERCENT (10%) CONTINGENCY FOR UNFORESEEN CIRCUMSTANCES; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE AGREEMENT WITH SUN-UP ENTERPRISES INC.; AND PROVIDING AN EFFECTIVE DATE.

17 **WHEREAS**, the 40th Year Community Development Block Grant (CDBG) Public
18 Works Improvement Project involves public works and utility infrastructure improvements,
19 including drainage improvements, sidewalks and landscaping in the City’s neighborhoods;
20 and

21 **WHEREAS**, an Invitation to Bid #FY 2014-2015-018, for the 40th Year CDBG
22 Public Works Improvement Block Grant Project, was provided by email to two hundred
23 nine (209) vendors; and

24 **WHEREAS**, a total of four (4) bids were submitted on October 21, 2015. Staff
25 evaluated the responses from the vendors, and Sun Up Enterprises was selected as the
26 lowest responsive, responsible bidder with a bid amount of one hundred six thousand nine
27 hundred ninety nine dollars (\$106,999.00); and

30 **WHEREAS**, Broward County concurs with the City Administrations determination
31 that Sun Up Enterprises is the lowest responsive, responsible bidder and the County has
32 awarded the City of Hallandale Beach one hundred eight thousand two hundred dollars
33 (\$108,200.00) for the project; and

35 **WHEREAS**, the City Administration recommends the award of Bid #FY2014-2015-
36 018, for the 40th Year CDBG Public Works Improvement Block Grant Project to Sun Up
37 Enterprises as the lowest responsive, responsible bidder.

39 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE**
40 **CITY OF HALLANDALE BEACH, FLORIDA:**

42 **SECTION 1. City Commission Award.** The Mayor and City Commission

43 hereby award Bid #FY 2014-2015-018, for the 40th year CDBG Public Works Improvement
44 Block Grant Project, to the lowest responsive, responsible bidder Sun Up Enterprises in
45 an amount not-to-exceed one hundred six thousand nine hundred ninety nine dollars
46 (\$106, 999.00).

48 **SECTION 2. City Manager Authorization.** The Mayor and City Commission
49 hereby authorize the City Manager to execute an agreement with Sun Up Enterprises in
50 an amount not-to-exceed one hundred six thousand nine hundred ninety nine dollars
51 (\$106,999.00), and authorizing a ten percent (10%) contingency for unforeseen
52 circumstances and authorize the City Manager to execute all related documents to
53 effectuate an agreement.

55 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon
56 its passage and adoption.




