RESOLUTION NO. 2015 - 35

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDBID #FY 2014-2015-007, CUSTODIAL SERVICES TO THE LOWEST RESPONSIVE, RESPONSIBLE BIDDER, SAFEGUARD SERVICES, INC. IN AN AMOUNT NOT TO EXCEED FIFTY ONE THOUSAND SIX HUNDRED NINETY SIX DOLLARS (\$51,696.00) PER YEAR FOR THREE (3) YEARS; AND PROVIDING FOR AN EFFECTIVE DATE.

14 **WHEREAS**, on December 3, 2014, the City Commission rejected all bids received
15 in response to an Invitation to Bid ("ITB") for custodial services through Resolution 2014-
16 142, and authorized a re-release in order to allow City Administration to include a defined
17 daily schedule for janitorial services for both the Police Department and City Hall; and

18 **WHEREAS**, on January 23, 2015, the City Administration released a second ITB
19 for Custodial Services with a clearly defined daily schedule of janitorial services required
20 to fulfill the needs of the Police Department for seven (7) days and City Hall for five (5)
21 days a week; and

22 **WHEREAS**, Bid #2014-2015-007 Janitorial Services was emailed to fifty (50)
23 vendors registered to provide this service through the City website, Sun Sentinel,
24 Demandstar and the Chamber of Commerce; and

25 **WHEREAS**, on March 6, 2015, the City received a total of fifteen (15) responsive
26 bids, of which four (4) were responsive to Bid #2014-2015-007; and

27 **WHEREAS**, the City Administration recommends awarding Bid #2014-2015-007
28 for custodial services to the lowest responsive, responsible bidder, Safeguard Services,
29 Inc. for an amount not to exceed fifty one thousand six hundred ninety six dollars (\$51,
30 696.00) annually for a three (3) year period.

31 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY
32 COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

33 Section 1. Award of Bid #2014-2015-007 to Safeguard Services, Inc. The
34 Mayor and City Commission hereby award Bid #FY 2014-2015-007 to Safeguard
35 Services, Inc. as the lowest responsive, responsible bid for an amount not to exceed fifty
36 one thousand six hundred ninety six (\$51,696.00) dollars per year.

37 Section 2. City Manager Authorization. The Mayor and the City Commission
38 hereby authorize the City Manager to execute all necessary documents to effectuate the
39 project.

40 Section 3. Effective Date: This resolution shall be effective immediately upon its
41 adoption.
