RESOLUTION NO. 2015 - 26

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA AUTHORIZING THE CITY MANAGER TO AWARD BID #FY 2014-2015-006, DISPOSAL SERVICE FOR YARD AND BULK WASTE, CONSTRUCTION, HURRICANE, AND OTHER RELATED DEBRIS TO THE LOWEST RESPONSIVE BIDDER, WASTE MANAGEMENT INC., OF FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE.

14 **WHEREAS**, on October 1, 2014, City Commission authorized prior solicitations for
15 disposal service to be revoked due to a change in the scope of services through Resolution
16 2014-110; and

18 **WHEREAS**, on December 18, 2014, the City re-solicited bids for these services.
19 From a field of thirty six (36) solicitations sent to responsible contractors, the City received
20 two (2) bids which were reviewed by the Department of Public Works for scope of services,
21 verifying credentials and meeting qualification for lowest responsive Bid; and

23 **WHEREAS**, an analysis of the two (2) bids reflects the City's yearly cost under
24 Sun Recycling, LLC to be approximately seventy seven thousand dollars (\$77,000), while
25 the City's cost under Waste Management Inc., of Florida would be approximately fifty five
26 thousand five hundred forty dollars (\$55,540.00); and

27 **WHEREAS**, pursuant to Code Section 23-4, all purchases and contracts for
28 equipment, supplies, and contractual services exceeding fifty thousand dollars (\$50,000)
29 shall be based on competitive bids; and

30 **WHEREAS**, pursuant to Code Section 23-6, the City Manager shall have authority
31 to recommend awarding of a contract to the City Commission; and

32 WHEREAS, the City Manager recommends awarding Bid #2014-2015-006
33 Disposal Service for yard and bulk waste, construction, hurricane and other related debris
34 to the lowest responsive bidder; Waste Management Inc. of Florida, for an amount not to
35 exceed fifty five thousand five hundred forty dollars (\$55, 540.00) for Fiscal Year 2015.

36 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY
37 COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

38 Section 1. Authorization of City Manager to Award Bid #2014-2015-006 to
39 Waste Management Inc. of Florida. The Mayor and City Commission hereby authorize
40 the City Manager to award Bid #FY 2014-2015-006 to Waste Management Inc. of Florida
41 for an amount not to exceed fifty five thousand five hundred forty dollars (\$55,540.00). It
42 further ratifies the City Manager's execution of all necessary documents to effectuate the
43 transfer and expenditure of funds.

44 Section 2. Effective Date: This resolution shall be effective immediately upon
45 its adoption.
