RESOLUTION NO. 2015-30

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED THE HALLANDALE OPPORTUNITY PROJECT (HOP) RFP #FY 2014-2015-002 TO THE SOLE RESPONSIVE FIRM M.D. STEWART AND ASSOCIATES, INC. TO SERVE AS THE LEAD AGENCY FOR THE IMPLEMENTATION AND OVERSIGHT OF THE HOP PROGRAM; AUTHORIZING THE CITY MANAGER AND THE CITY ATTORNEY TO ENTER INTO NEGOTIATIONS WITH M.D. STEWART AND ASSOCIATES, INC., AND BRING BACK AN AGREEMENT FOR CITY COMMISSION APPROVAL AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission and Hallandale Beach Community Redevelopment Agency (HBCRA) established the Hallandale Beach Opportunity Project, which is a project innovatively designed to approach and provide job skills, training job placement assistance, local vendor capacity/utilization and job creation; and

WHEREAS, with the adoption of the Fiscal Year Budget 2014-2015 the City approved funding for the HOP program; and

WHEREAS, on October 14, 2014, the Hallandale Opportunity Project (HOP) Request for Proposal RFP #FY 2014-2015-002 was released; and

WHEREAS, there was one (1) responsive, responsible proposal received; and

WHEREAS, of the one (1) responsive, responsible proposal received, the evaluation Committee reviewed the proposal and invited the firm for oral presentations and a site visit; and

WHEREAS, the evaluation committee evaluated the proposer and scored according to certain criteria; and

WHEREAS, based on the ranking, the evaluation committee determined that M.D. Stewart and Associates, Inc. ranked/scored highest; and

WHEREAS, City Administration is recommending to the Mayor and City Commission that RFP #FY 2014-2015-002 be awarded to M.D. Stewart and Associates, Inc., as in the best interest of the City and residents; and

WHEREAS, the Mayor and City Commission have determined that it is in the best interest of the City to award RFP #FY 2014-2015-002 the Hallandale Opportunity Project (HOP) to M.D. Stewart and Associates, Inc.; and

WHEREAS, the Mayor and City Commission desire to authorize the City Manager and City Attorney to negotiate with M.D. Stewart and Associates, Inc., an agreement for the implementation and oversight services of the HOP program, reflecting the award of RFP #FY 2014-2015-002.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. Award of Request for Proposal. The Mayor and City Commission hereby award RFP #FY 2014-2015-002 to M.D. Stewart and Associates, Inc., for the implementation and oversight of the HOP program.

SECTION 2. City Manager and City Attorney Authorization. The Mayor and City Commission hereby authorize the City Manager and City Attorney to negotiate with M.D. Stewart and Associates, Inc., an agreement for the implementation and oversight services for the HOP program reflective of the award of RFP #FY 2014-2015-002 and to bring back an agreement for City Commission approval. The City Manager is authorized to take all necessary actions to implement the project.


SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
