

42 with the largest being in the amount of \$425,000 – **impact - not to exceed**
43 **\$530,000.**

45 **WHEREAS**, this budget amendment will amend the FY 2017-2018 adopted
46 budget as indicated in Attachment A of this ordinance; and
47

48 **WHEREAS**, the Mayor and City Commission have determined that it is in the
49 best interest of the City and its residents to amend the FY 2017-2018 adopted budget as
50 reflected in the attachment; and
51

52 **WHEREAS**, the Mayor and City Commission have determined that this proposed
53 budget amendment is timely under Florida Statutes 166.241 and is being adopted in the
54 same manner as the original adoption of the FY 2017-2018 budget.
55

56 **NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY**
57 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

58 **SECTION 1.** The foregoing “Whereas” clauses are confirmed as true and
59 incorporated herein.
60

61 **SECTION 2. Adoption of Budget Amendment.** The Mayor and City
62 Commission hereby adopt the budget amendment to the FY 2017-2018 adopted budget
63 as set forth in Attachments A of this ordinance.
64

65 **SECTION 3. Conflict.** All ordinances, parts of ordinances, resolutions, or parts
66 of resolutions in conflict herewith are hereby repealed, to the extent of the conflict.


68 **SECTION 4. Severability.** Should any provision of this Ordinance be declared


