RESOLUTION NO. 2018-140

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARING BID # 2018-2019-001 A1A BRIDGE PAINTING IMPROVEMENTS, TO THE LOWEST, RESPONSIVE BIDDER, SOUTHERN ROAD & BRIDGE, LLC IN AN AMOUNT NOT TO EXCEED THREE HUNDRED AND ONE THOUSAND THREE HUNDRED AND ONE DOLLARS (\$301,301); AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT TO EFFECTUATE THE PROJECT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all purchases of and contracts for equipment, supplies and contractual services, when the estimated cost shall exceed \$50,000 shall be based on competitive bids. Furthermore, pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager, shall have the authority to recommend to the City Commission award of contracts; and

WHEREAS, on October 22, 2018, the City released BID # FY 2018-2019-001 A1A Bridge Painting Improvements; and

WHEREAS, on October 27, 2018, a Mandatory Pre-Bid Conference was held at 11:00 AM and five (5) vendors were in attendance; and

WHEREAS, three (3) bids were received. Two of the firms, M&J Construction Company of Pinellas County, Inc. and Razorback, LLC were deemed not responsive as they did not provide the proper experience to meet the minimum qualification requirement. The only responsive bidder was Southern Road & Bridge, LLC; and

WHEREAS, Southern Road & Bridge, LLC was the lowest responsive bid at an amount not to exceed three hundred thousand dollars (\$300,000); and

WHEREAS, the City Administration recommends that the City Commission award BID # FY 2018-2019-001 A1A Bridge Painting Improvements to the lowest responsive responsible bidder, Southern Road & Bridge, LLC in an amount not to exceed three hundred and one thousand three hundred and one dollars (\$301,301); and

WHEREAS, the Mayor and City Commission have determined that the City Administration's recommendations are in the best interest of the City and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. City Commission Action. The Mayor and City Commission hereby award BID # FY 2018-2019-001 A1A Bridge Painting Improvements to the lowest responsive responsible bidder, Southern Road & Bridge, LLC.

SECTION 2. City Manager Authorization. The Mayor and City Commission hereby authorize the City Manager to negotiate and execute an agreement with Southern Road & Bridge, LLC for BID # FY 2018-2019-001 A1A Bridge Painting Improvements in an amount not to exceed three hundred and one thousand three hundred and one dollars (\$301,301). The City Manager is further authorized to negotiate and execute all related documents to effectuate this project.

SECTION 3. Effective Date. This Resolution shall become effective immediately upon its adoption.
