



42 agreement with the highest ranked firm, AETNA, and should negotiations with the highest ranked  
43 firm fail, to authorize the City Manager and the City Attorney to negotiate with the second highest  
44 ranked firms, Cigna Healthcare and Life Insurance Company, Solstice Benefits Inc., and National  
45 Vision Administrators LLC, in an amount not to exceed the budget of \$7,205,379, representing a  
46 3% increase over Fiscal Year 2018/2019 budgeted amounts; and

48 **WHEREAS**, a fiscal impact breakdown for each line of coverage will be included with the  
49 June 19th, 2019 Agenda Item; and

51 **WHEREAS**, the Mayor and City Commission have determined that it is in the best interest  
52 of the City and its residents to accept the recommendation of the city administration.

54 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**  
55 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

57 **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

59 **SECTION 2.** The Mayor and City Commission hereby award RFP # FY 2018-2019-004  
60 Group Medical with Pharmacy, Medical Gap Plan, Dental, Vision, Employee Assistance Program,  
61 Flexible Spending Account and Cobra Administration, to the highest ranked firm, AETNA in an  
62 amount not to exceed seven million two hundred and five thousand three hundred seventy nine  
63 (\$7,205,379) dollars and authorize the City Manager to negotiate and execute an agreement;  
64 should negotiations with the highest ranked firm fail, the City Manager is authorized to negotiate  
65 with the second highest ranked firms, Cigna Healthcare and Life Insurance Company, Solstice  
66 Benefits Inc., National Vision Administrators LLC,.

68 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its  
69 passage and adoption.
