RESOLUTION NO. 2014 – 138

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, APPROVING RFP# FY 2013-2014-006 CONTINUING SERVICES AGREEMENTS TO FIRMS LISTED IN EXHIBIT "A" FOR PROFESSIONAL ARCHITECTURAL, ENGINEERING, LANDSCAPE ARCHITECTURAL, SURVEYING AND MAPPING SERVICES ON AN AS NEEDED BASIS; AUTHORIZING THE CITY MANAGER TO EXECUTE AND NEGOTIATE THE CONTINUING SERVICES AGREEMENTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City issued a Request for Proposals (RFP) in accordance with the Competitive Negotiations Act (CCNA), Florida Statutes 287.055, and City Code Sections 23-14 through 23-16; and

WHEREAS, release of the RFP was advertised in the Sun Sentinel, as well as posted on the City's website and Demand star. In addition, city administration emailed an invitation to respond to all firms in the City's list of vendors for such services; and

WHEREAS, the RFP requested professional services in the area of professional architectural, engineering, landscape architectural, surveying and mapping services. Twenty-eight (28) proposals were received and the evaluation committee reviewed and evaluated the proposals; and

WHEREAS, the Firms listed in Exhibit "A" are capable of providing services under their particular disciplines. Furthermore, each firm submitted a Community Benefit Plan (CPB), which will become a part of the Agreement to be executed between the City and the respective firm. Once the Agreement has been executed, and as the need arises, the City will choose the best suited firm within the needed discipline to perform services for a particular task/project; and

WHEREAS, City projects, tasks and services with a cost of less than \$50,000 will be approved by the City Manager. Projects, tasks and services exceeding the City Manager's authority of \$50,000, will be brought back for City Commission approval by the Department Director/Project Manager; and

40 **WHEREAS**, similarly, any CRA projects, tasks and services with a cost of less than
41 \$25,000 will be approved by the Executive Director. Projects, tasks and services exceeding the
42 Executive Director's authority of \$25,000, will be presented to the Board of Director's for approval
43 by the Department Director/Project Manager; and

45 **WHEREAS**, approving RFP FY2013-2014-006, continuing services agreements for the
46 firms listed in Exhibit "A" for professional architectural, engineering, landscape architectural,
47 surveying and mapping services on an as needed basis will expedite the process for selecting a
48 firm to provide needed professional services while still complying with the policies and procedures
49 of the City's procurement policy; and

51 **WHEREAS**, the City Administration recommends that the City Commission approve RFP
52 FY2013-2014-006, continuing services agreements for the firms listed in Exhibit "A" for
53 professional architectural, engineering, landscape architectural, surveying and mapping services
54 on an as needed basis; authorizing the City Manager to execute and negotiate the continuing
55 services agreements; and

57 **WHEREAS**, the Mayor and City Commission have determined that the City
58 Administration's recommendations are in the best interest of the City and its residents.

60 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF**
61 **THE CITY OF HALLANDALE BEACH, FLORIDA:**

63 **SECTION 1. City Commission Action.** The Mayor and City Commission hereby
64 approve RFP FY2013-2014-006, continuing services agreements for the firms listed in Exhibit "A"
65 for professional architectural, engineering, landscape architectural, surveying and mapping
66 services on an as needed basis.

68 **SECTION 2. City Manager Authorization.** The Mayor and City Commission hereby
69 authorize the City Manager to negotiate and execute continuing services agreements for
70 individual firms, on an as needed basis in substantially the form attached as Exhibit "2".
71

72 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its
73 passage and adoption.




