**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF
THE CITY OF HALLANDALE BEACH, FLORIDA, REJECTING
BID NO. FY 2020-2021-010 - INFLOW AND INFILTRATION
PHASE 2A LATERAL PVC PIPE REPLACEMENT PROJECT
AND DIRECTING STAFF TO RE-ADVERTISE; AND PROVIDING
FOR AN EFFECTIVE DATE.**

WHEREAS, on September 16, 2021, the City of Hallandale Beach released Invitation to Bid FY 2020-2021-010 - Inflow and Infiltration Phase 2A Lateral PVC Pipe Replacement Project; and

WHEREAS, one (1) vendor, ATC Engineering, Inc., responded; and

WHEREAS, upon the Evaluation Committee's review of the vendor's submittal of documentation with the minimum requirements of the Invitation to Bid, it was unanimously determined that the vendor's submittals did not meet the minimum qualification requirements for #4 and #5; and

WHEREAS, City Administration seeks City Commission authorization to reject the lone submitted proposal and readvertise for the required services.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. Whereas Clauses. The foregoing "Whereas" clauses are incorporated herein.

SECTION 2. City Manager Authorization. The Mayor and City Commission hereby reject the single proposal received from ATC Engineering, Inc. and authorize the City Manager to readvertise for the required services.

SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
